One post of Chief Executive of Mangalpur Primary Agricultural Cooperative Society Ltd. under Dasarathpur Block is to be filled up by the way of direct recruitment on mark basis of the academic career of the candidates as per the guidelines issued by the Registrar of Cooperative Societies, Odisha, Bhubaneswar, vide memo no. 2858 dt.07.02.2011 and amended made by the Cooperation Department vide letter no. 1074 dt.05.02.2014. Application form can be obtained in person from the I/C Chief Executive of the society on payment of Rs.100/- (Rupees one hundred) only from dt.22.12.2023 to dt.11.01.2024 during 11 am to 2 pm (Except Holidays) in the Office of the Mangalpur PACS Ltd. The duly filled in application form along with the required self attested documents and money receipts in support of deposit of requisite fees should be submitted to the I/C Chief Executive of the Mangalpur PACS Ltd. in person and obtain the acknowledgement receipt latest by 4 pm on dt.11.01.2024 from the Office of the Mangalpur PACS Ltd.

Eligibility and Educational Qualification :

1. The candidate must belongs to the area of operation of Mangalpur PACS Ltd, if suitable candidates are not available within the area of operation of the society, then preference will be given to the candidate within the area of the Block if not then the District concerned.
2. The candidates must be a graduate in any discipline from a recognized university with computer proficiency.
3. Preference shall be given to the candidates having HDCM / M.A / M.Com / MCA / MBA / Diploma in Cooperative Management and Knowledge in Computer Application from the recognized University/Institution.
4. Age - A candidate must not be less than 21 years or more than 32 years of age as on dt.01.04.2023. The upper age limit shall be 37 in respect of persons belonging to SC/ST/OBC/SEBC/PHC Person/ Ex-Service man. The upper age limit shall be 45 years in respect of persons employed in any Cooperative Society.
5. Scale of Pay – Rs.5200/- Rs.20200/- with Grade Pay Rs.1900/- with usual D.A. as admissible, subject to fulfillment of condition as laid down in the order no. 18672 dt.31.07.2009 of the R.C.S. Odisha, Bhubaneswar and subject to capacity to pay by the society.
